

2018 Calendar of Wishes Door Contest OFFICIAL RULES

NO ENTRY FEE. NO PURCHASE OR OBLIGATION NECESSARY TO PLAY OR WIN.

To enter: Correctly answer the daily trivia question associated with each door opening between noon on the day of the opening and 11:59 am the following day ("Entry Period"). Daily winner will be notified via email. Limit one entry per person, per day.

Eligibility: First-time visitors to Orangetheory Fitness and local residents only.
